

What is a co-operative and what does being a member involve?

The Radstock Co-operative Society was established in 1868 and is a consumer co-operative. The Society is owned and run by its members who benefit from the services the Society provides. Each member has an equal say in what the Society does. Rather than rewarding outside investors, a co-operative shares its profits amongst its members.

To become a member

simply complete the application form and send with a cheque for £2 made payable to Radstock Co-operative Society. Alternatively, drop your £2 (cash or cheque) and form into your local Radstock Co-op store. Once your application has been approved by the Board, a share account is opened in your name so your £2 is not lost. Once you have been a member for 6 months you will be eligible to attend the annual general meeting and to vote in elections for the nominated members you want appointed as directors. After you have been a member for 2 years with a minimum of £50 in your share account you become eligible to stand for election to the Board of Directors.

Members enjoy special benefits such as discounts and invitations to members' only events. By becoming a member you can help shape the way the Society develops in the future. You can also have a say in the decision making process.
